ADDENDUM

Subject : Samagra Shiksha - Minutes of the meeting of the Project Approval Board held on 22nd March, 2023 to consider the Annual Work Plan & Budget (AWP&B) 2023-24 of Samagra Shiksha for the State of Mizoram - Addendum- reg.

The undersigned is directed to refer to the State Govt's letter No.A.55013/2/2019-SPO(SS) dated 12th May, 2023 regarding proposal for setting up of Sanitary napkin vending machine and incinerator for bridging the incinerator gaps in KGBVs of Mizoram.

Saturation of all KGBVs with incinerators for disposal of sanitary pads is one of the targets to be achieved as part of NITI Aayog's special campaign for women empowerment "Rashtriya Nari Sashaktikaran Abhiyan(RNSA)" and as on 24.02.2023, gap of 2 No. of KGBVs having incinerators was detected on the Google Tracker(shared by this Department). As such, the State of Mizoram was requested to assess fund requirements for bridging the incinerator gaps in KGBVs and to submit a proposal before the PAB 2023-24 (additional, in case PAB is already held).

After considering the request of the Govt. of Mizoram, the following addendum is issued for setting up of two incinerators and two sanitary napkin vending machines, one each at Elementary School and Secondary School.


Accordingly, the Minutes of the PAB meeting finalized for AWP&B of 2023-24 of Samagra Shiksha, Mizoram has now been amended. The detail of amendment is as under:

An additional amount of Rs. 0.60 lakh has been approved for installing one incinerator and one Sanitary napkin vending machine in Elementary school (KGBV Type - I) and one incinerator and one Sanitary napkin vending machine in Secondary School (KGBV Type - IV).
