Dear *SE / Madam,*

As you are aware, the meetings of Project Appraisal Board (PAB) for Rashtriya Madhyamik Shiksha Abhiyan (RMSA) for 2016-17 have been completed and the Ministry has already released Ad-hoc Recurring Grants for RMSA for the year 2016-17.

2. In order to enable this Department to process for release of balance of 1<sup>st</sup> installment of funds (both Recurring & Non Recurring) for RMSA, States/ UTs need to provide information/documents as indicated below:-

- (i) Provisional Utilisation Certificate (in the prescribed format as devised in GFR) for the year 2015-16 indicating opening balance as on 01-04-2015, total central and state share releases during the year, expenditure incurred and total funds available (unspent balance-state share as well as central share) with the State /UTs government as on date;
- (ii) Component-wise and item-wise expenditure statement;
- (iii) Physical and financial progress in respect of previous releases;
- (iv) Certificate to the effect that State Govt. has released its minimum mandatory state share with statement indicating year-wise releases and cumulative deficit or excess in State Share released;
- (v) Budget provision made available by State/UT government towards central and state share for the year 2016-17;
- (vi) Update the status on PMS of RMSA;
- (vii) Audit Report for 2014-15, if not sent earlier;

3. I would like to further reiterate the instructions of Secretary (SE&L) during PAB meetings that all States/ UTs shall release School Grants to the schools out of the ad-hoc grants/unspent balances immediately so that the Schools may plan and utilize the funds in an efficient manner. A status report in this regard may also be sent.

4. I would request for your personal intervention to give instructions to the concerned to send the complete proposal as indicated in para 2 above by 30<sup>th</sup> May, 2016 to facilitate the Ministry to release the balance of 1<sup>st</sup> instalment in June 2016.
