Subject : Setting up of Sector Skills Council (Education).

1. In pursuance of the decision taken for setting up a Sector Skills Council in the Education Sector in the Meeting of the Steering Committee on Skill Development held on 17th September, 2014 under the Chairpersonship of Hon'ble Human Resource Minister , the Sector Skills Council (Education) is hereby notified as follows:
2. Role of the Sector Skills Council (Education) :
Covering job roles other than academic faculty in Universities and Colleges and teacher qualification in school education
3. The functions of the Sector Skills Council (Education) will be :
 - Setting up of Labour Market Information System (LMIS) to assist planning and delivery of training
 - Identification of skill development needs and preparing a catalogue of skill types
 - Develop a sector skill development plan and maintain skill inventory
 - Developing skill competency standard and qualifications
4. The composition of the Governing Council of the Sector Skill Council (Education) shall be as under: -
