**NOTICE INVITING EXPRESSION OF INTEREST**

**Objectives of the Scheme**

1. To set up 2,500 model schools as benchmark of excellence in blocks other than Educationally Backward Blocks (EBBs) at the rate of one school per block.
2. Model Schools will operate Classes VI to XII and shall have minimum infrastructure and facilities of same standards as in a Kendriya Vidyalaya(KV)

**Location**

1. Schools shall be located in Headquarters of Blocks that are not educationally backward.
2. Initially, 500 blocks will be identified for setting up of Model Schools in the first phase.

**Broad Roles of Private Entity and MHRD**

1. Private Entity shall procure the land for Model Schools and develop, design, build, finance, provide infrastructure, operate, maintain, manage and own these Schools.
2. The MHRD will contribute to recurring cost on per capita basis for the students sponsored by the Government. Besides, additional 25% of such support will also be provided in respect of sponsored students as infrastructure grant. The initial contract for such provision of quality education would be 10 years for each school, which is extendable as per mutual agreement.

**Last date for submission of EoI is 16<sup>th</sup> April 2012** upto 1700 hours IST. **Bidding Process**

Department of School Education and Literacy (DSEL), Ministry of Human Resource and Development (MHRD) invites Expressions of Interest (EoI) from Private Entities, which may be a Section-25 Company/Trust/Society, either as a single entity or consortium and for a consortium its Lead member, meeting the following eligibility criteria:

- (i) An entity running at least one CBSE School from where at least two consecutive batches have passed out from Class 10 will qualify for upto 3 schools.
- (ii) Those who have not come up to the Board examination level will qualify for one school.
- (iii) An entity would qualify for 3 schools if it has a track record of running educational institutions for at least 5 years and if it makes an interest-bearing deposit of Rs 25 lakh for each school, to be released in 3 annual instalments after commissioning.
- (iv) A Corporate Entity would be eligible for one school for every Rs 25 crore net worth subject to interest-bearing deposit of Rs 50 lakh each for upto 3 schools and Rs 25 lakh per school thereafter.

Applicants are required to submit necessary documents/certificates in support of the eligibility criteria mentioned above and shall include organizational brochures and audited financial statements (for last 3 years). EoI is being issued for initial screening of the interested applicants.
